## 2019 Husky Color Run Waiver

ALL PARTICIPANTS MUST READ AND SIGN. PLEASE READ CAREFULLY BEFORE SIGNING THE ACKNOWLEDGEMENT, WAIVER, AND RELEASE FROM LIABILITY. I acknowledge that The Husky Color Run 5k is a test of a person's physical and mental limits and it carries with it potential for death, serious injury, and property loss. I HEREBY ASSUME THE RISKS OF PARTICIPATING IN THE HUSKY COLOR RUN. I certify that I am physically fit, have sufficiently trained for participation in this event, and have not been advised otherwise by a qualified health professional. I hereby take the following action for myself, my executors, administrators heirs, next of kin, successors and assigns, or anyone else who might claim or sue on my behalf, and I expressly acknowledge that it is my intent to take these actions: (a) I AGREE to abide by the rules of the Husky Color Run (b) WAIVE, RELEASE, AND DISCHARGE FROM ANY AND ALL CLAIMS, LOSSES, OR LIABILITIES FOR DEATH, PERSONAL INJURY, PARTIAL OR PERMANENT DISABILITY, PROPERTY DAMAGE, MEDICAL OR HOSPITAL BILLS, THEFT OR DAMAGES OF ANY KIND, INCLUDING ECONOMIC LOSSES AND LOSS AND/OR STOLEN ITEMS, WHICH ARISE OUT OF OR RELATE TO MY PARTICIPATION IN, OR MY TRAVELING TO AND FROM THE EVENT, THE FOLLOWING PERSONS OR ENTITIES: The Husky Color Run sponsors, Bloomsburg University, Bloomsburg Women's Basketball, race directors, employees, event owners, volunteers, the town or county where the event is held, and the officers, directors, employees, representatives, volunteers, and agents of any of the above even if such claims, losses, or liabilities are cause by the negligent acts or omissions of the persons I am hereby releasing or are caused by the negligent acts of any other person or entity; (c) I ACKNOWLEDGE that there will be traffic on the course route, and I ASSUME THE RISKS OF RUNNING AND PARTICIPATING IN THIS EVENT. I ALSO ASSUME ANY AND ALL OTHER RISKS associated with participating in this even including but not limited to falls, contact and/or crashes with other participants, effects of weather including heat and/or humidity, defective equipment, the condition of the roads, water hazards, complications from color on clothing and person, and any hazard that may be posed by spectators or volunteers all such risks being known an appreciated by me, and I further acknowledge that these risks include risks that may be the negligence of the persons or entities mentioned in above paragraph (c) or other persons or entities; (d) I AGREE NOT TO SUE ANY OF THE PERSONS OR ENTITIES MENTIONED ABOVE IN PARAGRAPH (c) for any and all claims, losses, or liabilities that I have waived, release or discharged herein; (f) I INDEMNIFY AND HOLD HARMLESS TH EPERSONS AND ENTITIES MENTIOND IN PARAGRAPH (c) for any and all claims made or liabilities assessed against them as a result of (i) my actions or inactions, (ii) the actions, inactions or negligence of others including those parties hereby indemnified; (iii) the condition of the facilities, equipment, or areas where the vent is being conducted; (iv) the Rules; (v) any other harm caused by an occurrence related to the Husky Color Run event; and (g) I GRANT PERMISSION for the use of my name and/or likeness relating to my participation in THE HUSKY COLOR RUN event. And I waive all right to any future compensation to which I may otherwise be entitled as a result of the use of my likeness; (h) I UNDERSTAND and accept that my entry fee is non-refundable under any circumstances.
